
The Top Achievers Conference



What To Expect And When To Expect It

Registration Opening!

Registration opens the beginning of February. Your credit union will let you know if you have qualified for TAC.

The Third Party Travel Agent reaches out to registered attendees. Registered Attendee's information is sent every Friday at noon to the Travel Agent. If you register late Friday afternoon, the travel agent won't get your registration until the following Friday.

Event Materials Received!

Once registration closes, the Welcome Packets are placed together. Roughly one month prior to the event, you will receive your Welcome Packet and Agenda.

Last Day to make changes!

IWS understands that life happens, and plans change. IWS will do everything possible to accommodate changes. Additions to our party cannot be fully accommodated within 30 days leading up to the event.



Planning Your TAC Travel

The following are frequently asked questions and general information regarding TAC. Please contact the IWS Marketing Coordinator for additional information or questions.



I want to bring a Guest to TAC. What does that look like?

IWS encourages you to bring a plus one, however, we do not pay for any plus one expenses. Additional charges are as follows:

• There is the option to invite them to our events for an additional fee to cover their food and beverage. The fee is assessed every year.

• Hotel rooms are covered by IWS, however, we do pair up credit union employees from the same credit union and same gender attendees. You can request your own room or buy out the room if you have a guest attending. This cost is assessed based off room pricing and group rate.



When should I expect to hear from the Travel Agent?

Our chosen Third-Party Travel Agent will reach out to you directly once your registration form has been filled out and the Travel Agent receives your information. The IWS Marketing Coordinator sends the registration information to the travel agent on a weekly basis.



All TAC Attendees travel must be coordinated by the IWS Travel Agent.

The travel agent books all TAC attendee flights and coordinates all billing directly with IWS' to book approved attendee flights. IWS does not reimburse attendees for travel booked outside of this process.



What about my guest's flight?

Attendee guest flights can be purchased at the same time as attendee flights and the attendees credit card will be requested for the guest flight.
